Automated Extraction of Occupant Injury Results

1 Introduction

There are an increasing number of standardized tests, for which a vehicle should comply with and all these tests, usually, require the generation of a standardized report.

For the generation of reports for simulated tests, after each solver run, the followed post-processing actions are always the same. In addition, for Occupant Safety tests the use of different dummies per test, adds more similar post-processing actions.

This repetition is proven cumbersome, time-consuming and prone to errors. Therefore, the automation of the execution of those actions and the subsequent report generation is required.

Apart from automating the repeated post-processing actions another problem is to compare the results of the simulated tests with the physical tests results.

This paper presents a software tool developed in μ ETA (mETA), the Post-Processor of BETA CAE Systems S.A., that automatically processes and creates reports for Occupant Protection in Interior Impact.

2 µETA Tools for Automation

The automation requirements are facilitated by three different tools in µETA:

- the user toolbars
- the session files
- the scripts

Each of these can be used alone as well as in combination with the others so as to deliver the maximum level of automation in each case. Added to this, the effortless creation of automated procedures is greatly assisted through respective editors for each of these tools.

What can be achieved with these tools:

- Combination of 3d and 2d tasks
- Custom GUI: User Toolbars, GUI Library functions for scripting
- Direct access to all analysis' results through respective commands
- Fully automated reporting (html, pptx, pdf, ps)
- Automated processes can be executed before, after or between manual processes
- Created processes can be shared among different levels (company, group or user level)

Based on these automation capabilities BETA CAE systems has developed a suite of standard tools to automate the post processing and the creation of reports for Pedestrian Safety analysis, Occupant Protection in Interior Impact (FMVSS 201U), IIHS structural ratings, Bus Rollover (ECE R66) and recently Occupant Injury results. These are included within the standard installation of mETA.

These tools streamline the extraction of the results for the respective tests. They lead directly to reports and create overview models for supervisory evaluation in cases of a large number of simulation runs.

3 Occupant Injury Criteria tool

The last addition in this suite of tools is the Occupant Injury Criteria tool which automates the extraction of occupant injury results.

Different dummy types can be processed simultaneously from many simulations and physical tests and the results are overlaid in order to be compared. The tool provides an efficient and easy manipulation of the created results for better inspection and comparison of them.

Apart from extracting the standard required results for each dummy the analyst can easily add more results for each dummy or more results of the vehicle in order to perform a full analysis.

3.1 Supported file formats and dummies

The tool can extract results from LS-DYNA and other solvers. For physical test results ISO data files are supported. The dummies which can be processed are:

3.2 Interface

The tool is mainly divided in three tabs. In the first tab, the Read Results tab, all the input that is needed from the tool in order to create the results must be added. For example if the tool will run Simulation or Physical Test results or both, file formats and unit systems for Simulation and Physical Test, Impact Type, Regulation, how many dummies exist in the car during the test and then for each dummy it's type, version, if limit curves will be created, etc.

In the second tab, the Settings tab, there are options for the output unit system, trimming of curves time, curves coloring, etc. From the third tab, the Results handling tab, it is possible to apply focus commands on curves on processed variant level, edit the curves after they are created etc.

3.3 Extracted Results

The tool searches the given results directory and lists all the found results (first for simulation and then for physical test results). The user can select from these lists the Simulation variants and Physical test runs for which results will be created.

From each selected Simulation or Test run, results for up to 4 dummies can be created. One page is created for each processed dummy with results calculated by the Solver or results coming from the Physical test and Crash Analysis Criteria calculated by µETA.

In this page one Summary window exists with all the results that are needed to evaluate this dummy.

Apart from the window with summary of results one window for each type of results is also created in order to view these results in more details.

The tool extracts the standard results that are required for the evaluation of each dummy but it is also possible to extract additional results either for each dummy or results of the vehicle in order to perform a complete analysis. These are completely user defined results.

3.4 Results Handling

After the results are created, each processed variant (Simulation and Physical Test) is added in the Run drop-down menu of the Results Handling tab of the tool. By selecting a Run from this drop-down menu the user can apply focus commands (show only, hide, show) to the curves of this Run. This way when many Simulations and Physical Tests are processed the comparison between them becomes easier.

It is also possible to load the 3d results (geometry of the model and displacements) of a selected simulation Run in order to see what exactly happened in this simulation. This way all the capabilities of μ ETA for 3d Post-Processing can be used, such as having the same views like in the physical test, creation of cut-planes for better visualization of results, easy identification of critical results, importing videos of the physical test and correlating these videos with the simulation.

3.5 Future Developments

3.5.1 Reports

The tool currently extracts the Occupant Injury results and from its next version it will be able to create automatically reports. Standard Power Point reports will be created, according to the selected Regulation, which will contain tables with all the needed results and images of the results (curves). Apart from adding the results to Power Point reports, the results will be added in spreadsheet files, such as the Euro-NCAP-Spreadsheet.

3.5.2 Dummies, Solvers, Results

In the future the tool will support more dummy types, such as BioRID-II, Q10 for Side Impact, THOR. More Solvers and file formats for Physical Test results will be supported too. Finally the calculation of more Crash Analysis Criteria will be added in µETA, such as Nkm, NIC, Time At Level, BrIC, etc.

4 Summary - Benefits from using the Occupant Injury Criteria tool

The Occupant Injury Criteria tool streamlines the Post-Procesing and the report generation with a few clicks assuring an error free outcome. It provides efficient and easy manipulation of the created results for better inspection and comparison of them. It is designed according to the respective regulations but it can be customized according to the engineer's needs.

Using μ ETA and the Occupant Injury Criteria tool an engineer can post-process the 3d animations of simulation results, extract the Occupant Injury results (curves) from simulations and physical tests and compare them and correlate also the 3d animations of simulations with the videos of physical tests, using only one software. This software (μ ETA) can be easily coupled with LS-OPT (along with ANSA, the Pre-Processor of BETA CAE Systems S.A.) in order for the engineer to optimize the results.
